Office Bearers' Reports

Chair's Report



Dr Pam HardyChair, Faculty of Pre-Hospital Care

It has been an incredible year for the Faculty of Pre-hospital Care (FPHC) with numerous positive outputs, thanks to significant work by many of our members and the Faculty office team.

At the beginning of the year, we were cited in the Manchester Arena Inquiry to provide a statement regarding the remit of FPHC and our proposed actions against the Volume II monitored recommendations. Much work went into this supported by Beth Stevenson, Faculty Manager, and the Royal College of Surgeons of Edinburgh (RCSEd) and was undertaken as requested by the Chair of the Inquiry in collaboration with the College of Paramedics, the National Ambulance Resilience Unit and NHS England.

Our involvement in the Manchester Arena Inquiry escalated the profile of the FPHC to a new level and we are now seen as a key collaborator in the work being taken forward by NHS England. We have representatives on individual Task & Finish groups addressing the monitored recommendations, and I have been co-opted onto the NHS England Strategic Oversight Group.

It also acted as a catalyst to the final sign-off of the long-awaited Diploma in Major Incident Management (DIMM), which was launched in October, with a mock exam taking place in January and first diet in July 2024.

We received a strong statement of support for the launch of our Diploma from the Chair of the Inquiry, the Hon. Sir John Saunders.



Following a proposal and discussions, the Intercollegiate Board for Training in Pre-hospital Emergency Medicine (IBTPHEM) is now hosted by FPHC and RCSEd. This feels like an appropriate step for this Board, with the DIMC and FIMC exams being the summative assessments for PHEM training, whilst also open to a multi-professional audience. We are extremely grateful to RCSEd for their continued insight into this important development and the wider multi-professional aspects that we strongly believe achieve the best outcomes for our patients.

There has been a positive response from the GMC regarding the implementation of the updated 2022 IBTPHEM curriculum, led by Dr Nathan Howes, showcasing excellence not only in patient care, but also training and the needs of trainees.

The Pre-Hospital Emergency Medicine Trainees' Association (PHEMTA) Group has been busy supporting trainees as detailed in their report.

We ran the very successful FPHC Conference on the 6th & 7th November in the College. Our thanks go to Professor David Lockey, and to Gordon Ingram with the organisation and delivery of future conferences now being moved to a specific Conference organiser role. The event was sold out and exceeded capacity of the College, with approximately 260 delegates attending over the 2 days, and a further ~ 100 on a waiting list. The delegates comprised members and non-members, students, and non-healthcare professionals, with multi-professional representation and a positive atmosphere of engagement and excellent programme of speakers.

We have been working with the Communications Committee and the RCSEd Marcomms team uploading resources from the conference including an excellent podcast from Paramedicast and many of the 50+ posters we had displayed, as well as news items about the poster winners and presentations of our Honorary Fellowships and FPHC Medals.

Honorary Fellowship of the Faculty was awarded to Professor Karim Brohi and Professor Hans Morten Lossius for their outstanding contributions in their respective fields of work and to pre-hospital care. The recipients of the FPHC Medal were Professor Tim Nutbeam and Mr David Whitmore.

Our exams go from strength to strength, with full diets of both the Diploma in Retrieval and Transport Medicine (DRTM) and Diploma in Urgent Medical Care (DUMC) this year, as well as the continued popularity of the Diploma and Fellowship in Immediate Medical Care. A total of 364 candidates attended for our exams in 2023. DIMM will commence July 2024.

The Diploma in Remote & Offshore Medicine (DipROM) programme is undergoing review led by our Executive Lead David Whitmore, with some new recruitment to module tutors and markers and as well as starting conversations with the Faculty of Remote, Rural and Humanitarian Healthcare and the Worshipful Society of Apothecaries to explore possible collaboration on modules.

The Crowd Doctors and Practitioner courses remain so popular that additional course dates have been added.

Our Faculty Advisory Board (FAB) has been extremely well-attended with an agenda and productive discussions that reflect the recognition of the collaborative hub of the FPHC. This includes everything from the need to address initial interventions by members of the public, to the request for position statements around high acuity low occurrence events.

All the statutory and voluntary emergency services are looking to us to help set national standards across their agencies and share these across military and civilian practice where applicable.

Discussions are ongoing with The University of Central Lancashire (UCLAN) around development of an MSc in Pre-hospital Care for those without a primary degree. This is already in place for the DUMC and is a model that fits with some of our other exams.

Work is ongoing to refresh and write new consensus documents, now supported by a new Chair and members of the Clinical Standards Committee. The Faculty Webinar programme delivered a number of well attended episodes in 2023.

Our international reach has increased considerably following the FPHC Pre-Hospital Workshop held in India in association with the RCSEd International Conference in 2022, led by Dr David Bruce. He and his team delivered two inaugural Pre-Hospital Trauma Care (PHTC) courses in Chennai in April 23.

The courses were delivered at, and strongly supported by, the Sri Ramachandra Institute of Higher Education and Research (SRIHER). Funding was provided by the UK-registered charity Saving Lives International.

To promote local training, a 1-day Instructor Course was delivered in October 23 and a subsequent Provider Course to new candidates over the next 2 days. In keeping with the FPHC's multidisciplinary membership, 3 of the 12 Instructors trained were Indian paramedics. The next PHTC Course is scheduled to be held in Kathmandu, Nepal in February 2024.

Work has also been ongoing around a tactical pre-hospital care course for colleagues at the European Security Academy in Poland with endorsement of the course content and further potential for endorsing a course delivered by the British Army in Kenya.



Several members of FPHC were invited to the launch/re-branding of Saving Lives International at the House of Lords in September 23. We engaged with the Ambassador of Nepal to the UK and the High Commissioner of Uganda to the UK; both are interested in extending training within their nations.

David Bruce is standing down as FPHC International Development Lead after 5 years in this role, achieving this and much more including liaison with many other countries. Our huge and heartfelt thanks go to him for all his work on behalf of FPHC.

Further detail and much more is contained in the committees and groups reports below and I urge you all to read them. I extend my thanks to everyone who has contributed. There really is so much work that is being done that I am unable to capture ait all here. We have welcomed some new members, office staff and appointments, and I would also like to thank those who have demitted from their terms of office this year. I remain immensely grateful for the hard work of Beth and the office team without whom none of this would be possible. It is maybe timely that the Communications Committee has been regenerated and already started to produce some great work showcasing the achievements of FPHC and raising our profile. We look forward to their continued engagement with our members, including through our regional groups to further share our purpose and progress.

Thank you to all our members for your continued support to the Faculty of Pre-hospital Care.

Preparations progress to deliver a new Diploma in Major Incident Medical Management. A mock exam will take place in January 2024 and the first formal diet in June/July 2024. To deliver this new diploma a much appreciative collaborative process with the college Education department, who continue to guide the development team. A huge effort by the exam writing team and editorial group lead by Deputy Convenor Dr Paul Hunt is underway. The examiners and candidates have been identified for the mock examination. I wish to offer my gratitude to all engaged in this new diploma.

Faculty activity is picking up well now that we are in post-covid mode and this is reflecting in our finances. The details of increasing activity have been reported by my fellow office bearers so I will not re-iterate them here. Because of timing and notice issues for the AGM the final accounts for the Faculty are not yet available but we have three quarters data to the end of September 2023. Based upon that data our income was £33,609 ahead of budget and our expenditure £43,324 behind budget.

Our budgeting processes have been long developed, regularly reviewed and intrinsically robust and therefore barring any unforeseen significant changes we are on target for a surplus of around £50,000. This must be taken in context that we have still to evaluate the final financial outputs of the very successful FPHC conference in November which was 50% oversubscribed and if we are to consider meeting such demand in future that will affect our future cost base.

All in all, the finances are healthy and able to sustain our programme for development.

I would like to thank the Office Bearers, the FPHC Executive Committee and the Faculty Office for their support.

Pre-Hospital Care Examinations Committee

Examiner training and revalidation — the RCSEd educational and psychometrics team have developed an online examiner training package, and this was utilised for the DUMC, and feedback has been gathered. We will use this for the January IMC exams. I hope this will reduce the costs associated with the exam diets as examiners will not need to be in Edinburgh to complete this.

DIMC/FIMC

We have reviewed the implementation of the new IBTPHEM curriculum for the GMC. As a result, we have (for all candidates, not just PHEM trainees):

- Improved coding of pass/fail/resit.
- Improved capture and collation of monitoring data.
- Exams outcomes have been analysed. We see a similar pattern of pass rates year on year. With improved coding of first attempt/resit the data will be more usefully interpretable going forward.
- Implemented additional E&D training for examiners.

We are looking to:

- Analyse exam results by capabilities and themes.
- Develop and triangulate quality management data sets (and identify any unanticipated areas of bias or discrimination) relating to assessments.

DipMIM

A mock exam is being held in January 2024 with a diet planned for the summer 2024. There have been applications and eligibility requests for the diet. The work by Dr Paul Hunt and Dr Andy Smith on this has been outstanding.

DUMC

Work is ongoing to look at these results to ensure the eligibility criteria and pre-exam information allow candidates the best chance of success. As a result of feedback, we have already made some changes to these criteria to ensure that only clinicians with sufficient relevant training and experience meet the eligibility criteria.

DRTM

The syllabus for the exam is due for review and updating and this work has been taken on by Dr Matt O'Meara, Dr Andrew Cadamy and Dr Terry Martin.


The work for the DRTM to link in with the University of Central Lancashire (UCLAN) as per the agreed MoU continues, although has been largely static over the last year for a variety of reasons. This is led by Dr Terry Martin.

Dr Alistair Newton has now demitted his role as Lead Examiner for the written exam. Dr Louise Webster and Dr Matt O'Meara have formally assumed this role, after working with Alistair for the 2023 diet. I would like to thank Alistair for his hard work over several years in revising and improving the written content of the exam; and welcome Louise and Matt.

Having moved to the Deputy Convener role, Neil Hughes has demitted their role as OSPE Lead Examiner, and this has been taken over by Dr Ami Jones and Mr Jeff Proctor. Welcome Ami and Jeff and thank you for your hard work on the 2023 diet.

Training and Standards Committee

Chair, Training and Standards Committee

The Training and Standards (T&S) Committee have continued to assess courses for endorsement during 2023. The committee membership has changed slightly over the last year. Mr Tony Kemp stood down and I wish to officially record my thanks to Tony for his support and contributions to the T&S Committee during his membership. Mr Kev Wheeler and Mr Steve Shackleton have joined the committee after open advertising and competition; both have already made significant contributions and we are delighted to welcome them to the team.

There remain three levels of support for courses. Firstly, where the concept of a programme is supported; secondly where the content is endorsed; and thirdly where the content and delivery are endorsed. There is also an endorsement assessment matrix for overseas courses which allows slightly greater flexibility informed by local constraints. The endorsement process for most courses includes a review of all the course materials, delivery, course policies, including assessment, instructor identification and training. This includes a visit to the training location during a course; hence, there is a considerable amount of work involved and I am grateful to the committee members for their engagement. Courses are reported upon using structured matrices and templates. The committee agreed that reports should be copied to training providers as part of the formative process; this had generally occurred in the past but is now part of T&S Cttee policy.

New applications for endorsement have shown a slight increase during the year. Some training providers have decided not to seek re-endorsement, but this has been because they no longer deliver the course rather than them not valuing the endorsement process. Although cross-recognition of sports courses is not a matter for the T&S Committee, this rests with the sports' governing bodies, there had been occasional confusion in the minds of candidates, and we previously tightened up our endorsement letters to make the issue totally clear. This appears to have resolved the issue although we keep a close eye on this area and are fortunate that the Hon Sec is closely involved in many sports courses and acts as a conduit for concerns.

The endorsement matrix previously demanded an MCQ as part of the summative assessment and this was debated at length after a training provider highlighted that the results of this test this did not necessarily show a good correspondence with candidates' performance on the rest of the course. Moreover, candidates on some pre-hospital courses are practical individuals and find formal MCQs threatening which can detract from the overall learning experience. The committee agreed that an MCQ should no longer be a compulsory element. However, if an MCQ is not used, we require that the training provider can provide records demonstrating reproducible, acceptable and accurate methods of confirming that candidates have assimilated the training to a safe standard.

During the year, we finalised the endorsement assessment of a course presented by Polish colleagues; this task has taken considerable effort and we provided significant guidance on focusing the course and rewriting presentations. The course is endorsed for 'content only' but was our 1st endorsed course abroad. As described in the International Development Lead report, the FPHC ran 3 Pre-Hospital Trauma Care Provider courses in India in 2023; the course is endorsed. We have recently been approached for an endorsement assessment of a course being run in Kenya by the British Army and hope that this will add to the Faculty's international presence. Finally, and significantly, World Rugby Union and other sports courses run abroad are endorsed and this is largely through the efforts of the Hon Sec.

International Developments

Following on from the FPHC Pre-Hospital Workshop held in India in association with the RCSEd International Conference 'Beyond COVID-19: Impact & Innovation' in 2022, the FPHC delivered 2 inaugural Pre-Hospital Trauma Care (PHTC) courses in Chennai in April 23.

The courses were delivered at, and strongly supported by, the Sri Ramachandra Institute of Higher Education and Research (SRIHER). Funding was provided by the UK-registered charity Saving Lives International which supports the Faculty of Disaster Medicine – India and Nepal (FDMIN). FDMIN aims to improve training in all phases of disaster response and sees pre-hospital care (PHC) as having a key role in the initial response as well as contributing to reducing the wider, ongoing accident-related health burden in South Asia.

The UK version of the PHTC Course was edited to take account of current PHC capabilities and practice in India guided by information from the October 2023 workshop and input from local practitioners. In addition, a folder of supporting administrative documentation was developed to allow the planned dissemination of the course to other approved training centres and maintain consistency of training. The FPHC Foundation Material for Immediate Care Manual, in an e-format, was used as the reference text. The UK faculty comprised myself, Dr Lorraine Greasley and Dr Rob Russell and we were fortunate enough to be joined by Professor Ramakrishnan who is the Head of the Emergency Medicine Department at SRIHER and a key influencer in the development of PHC in India. Professor Ramakrishnan engaged with his PHC contacts, some of whom had attended the October 2023 Workshop, to ensure that we had a multi-disciplinary group of candidates from different locations across India. Dr Peter Patel of Saving Lives International invited candidates from Nepal. Ultimately, we had 41 candidates comprising 12 paramedics and 29 doctors from a range of backgrounds and including 4 from Nepal.

Feedback was received from all candidates and was excellent; the faculty were invited to deliver the course at other locations in India. However, in order to establish a firm foundation and local 'ownership', the ultimate aim is for the course to be delivered by selected India faculty at approved centres. Accordingly, candidates with Instructor Potential (IP) were selected across the two courses; we felt these individuals demonstrated the knowledge, practical skills, experience and enthusiasm needed to be effective instructors.

In October, 12 Instructor Candidates from the April cadre attended a 1-day Instructor Course at SRIHER delivered by Dr Rob Russell and Professor Ramakrishnan; they went on to deliver a subsequent Provider Course to 21 candidates over the next 2 days. In keeping with the FPHC's multidisciplinary membership, 3 of the 12 Instructors trained were Indian paramedics.

A further PHTC Course is scheduled to be held in Kathmandu, Nepal in February 2024 and UK and local faculty have been identified. This will generate further candidates with Instructor potential who will ultimately attend an Instructor Course with IP colleagues from the October Chennai Provider Course. We are gradually building up a local cadre of Instructors to take this initiative forward in S Asia. The plan is for the FPHC to carry out quality assurance visits on an approximately annual basis. Further details on the initiative were published in the September 23 issue of Surgeons' News.

The Chair and Vice Chair of the FPHC, with other members, were invited to the launch/re-branding of Saving Lives International at the House of Lords in September 23. We engaged with the Ambassador of Nepal to the UK and the High of Uganda to the UK; both are interested in extending training within their nations. Further detail was published on the FPHC website on 21 September 23. The event also delivered the opportunity to explore areas of mutual interest between the FPHC, Saving Lives International and this work is now being taken forward.

As mentioned in the T&S Committee report, there was a considerable amount of work put into refining and focusing a tactical pre-hospital care course for colleagues at the European Security Academy in Poland and this has resulted in endorsement of the course content. We are also looking at the potential for endorsing a course delivered by the British Army in Kenya focusing on risks and solutions to working in remote and austere 'bush' environments. The FPHC also has an international presence in endorsed sports courses through the efforts of the Hon Sec.

The FPHC Office staff have invaluable throughout the year and I would also like to record my thanks to the Chair of the FPHC who has been unswervingly supportive. In addition, this project would not have moved forward without the financial and professional support of Dr Peter Patel, Dr Rob Russell, Dr Lorraine Greasley and Professor TV Ramakrishnan.

Diploma in Remote and Offshore Medicine

We have analysed the figures for students undertaking the programme over the last few years and noted a general downwards trend to undertake certain modules, (Teaching and Learning, Evidence and Research in Remote Medicine and Health and Wellbeing in the Remote Worker are the most stark). Overall trend for student numbers declining, (169 in 2017 to 63 in 2023).

During October and November of 2023, the Tutors for the following modules stood down:_

- 1. Evidence and Research in Remote Medicine
- 2. Communication in the Clinical Consultation
- 3. Tactical Medicine

For the first two we have suspended the modules until further notice as they had no students. For the Tactical Medicine the 2nd marker and the Academic Co-ordinator have stepped in to run the module for the three students on that module. With regard to the Tactical Medicine module, we have formally appointed the previous 2nd marker as the module tutor and appointed a new 2nd marker.

This analysis supports the current view to reducing the number of modules and offering them as standalone CPD Modules for the more popular Modules – Dive Medicine being the prime example.

We are starting to have conversations with the Faculty of Remote, Rural and Humanitarian Healthcare to explore possible collaboration on modules. There is also a view we could seek the same with the Worshipful Society of Apothecaries.

A first draft of a Heat illness guideline has been produced and an updated traumatic cardiac arrest guideline produced. Guidelines on Crush injury and Pre-hospital ultrasound are at earlier stages. The faculty is also represented on the AAGBI Pre-hospital anaesthesia guideline group.

The Faculty Webinar programme delivered a number of well attended episodes in 2023.
